8. MEETING WITH THE DEPARTMENT OF LOCAL GOVERNMENT, RACING AND MULTICULTURAL AFFAIRS

Rebecca advised that she and Karen had met with the Department of Local Government, Racing and Multicultural Affairs (Department) on Friday, 11 January 2019. The meeting was initiated by the Department who indicated they were keen to partner with ALGWA in the coming year.

The Department also announced that funding had been approved for up to 40 participants to undertaken training through the Australian Institute of Company Directors (AICD). Details are yet to be confirmed with the Department in relation to the courses on offer and the total amount for the sponsorship. The Department are also preparing marketing material to be used for the offer.

Once details are confirmed, ALGWA will need to notify members as soon as possible. Councils will be required to pay for the course initially with the Department reimbursing the cost of the course upon successful completion.

Discussion took place on the possibility of ALGWA offering up to 3 travel packages of \$500 to support rural, remote and Aboriginal Councils to attend.

ACTION: Issue e-newsletter to members when details are confirmed.

9. ACTION ITEMS FROM WORKSHOP HELD 20 OCTOBER 2018

Rebecca drew member's attention to the action table from the workshop held 20 October 2018 and asked for any comments. Karen advised that she had completed the draft scrip and was working with Nikki on the brochure. No further comments.

Rebecca then spoke about the 5 agreed workshop topics - resilience & wellbeing, financial sustainability, CCC process, conflict resolution and media/social media. All agree with the workshop topics.

Discussion took place on locations to host workshops and the possibility of holding the same workshop across a number of locations.



It was agreed that the resilience and wellbeing workshop be delivered in Brisbane, Cairns, Townsville and Mackay. Jilinda will organise the Cairns workshop, Pierina the Townsville workshop, Jan the Mackay workshop and Karen and Nikki the Brisbane workshop. It was further agreed that this workshop will need to be consistent when delivering at the different locations.

Jo spoke about the possibility of inviting the Minister to attend the Financial Sustainability workshop.

Rebecca spoke about the importance of having clear and compelling reasons to seek financial assistance/sponsorship from the Department of Local Government and to be mindful that all funding must be spent and finalised by before the end of the financial year meaning events will have to be delivered by May.

3. NEW ALGWA PRESIDENT

Ms Rebecca Hersant advised via written notification on 14 January 2019 that she was resigning from the position of President of the ALGWA Queensland Branch to pursue career opportunities overseas.

Discussion took place on the importance of having an ALGWA President who lived in the South East Queensland corner and was able to attend meetings to represent ALGWA easily and regularly.

Further discussion took place on the need to have a clear strategy and messaging to promote ALGWA and encourage women to join. Further consideration of why we have not been successful in succession planning needs to be undertaken.

Various possible persons were discussed as possible people to approach to ask if they would consider standing at President until the next Annual General Meeting.

At this stage of the meeting the time being 2.50pm, Councillor Daphne McDonald joined the meeting.

Approaching members who would be retiring councillors who had experience in ALGWA executive positions was also discussed.

4. DEPARTMENT OF LOCAL GOVERNMENT, RACING AND MULTICULTURAL AFFAIRS FUNDING FOR AICD COURSES

Ms Rebecca Hersant advised that the Department was providing funding for ALWGA members to attend 2 AICD courses. These courses are being run exclusively for ALGWA Members and will not be open to the public.

The scholarship opportunities for ALGWA include full payment of the AICD course costs. Members will be required for their Council to pay the fee up-front and then get reimbursed following completion of the course.

Discussion took place on the possibility of Zone Members contacting each Council and promoting this opportunity as a way to obtain new members and also promote what ALGWA can offer.

Rebecca also advised that the Local Government Association of Queensland (LGAQ) had also been provided funding to run a number of courses that related to the Belcarra Reform.

Travel Packages for ALGWA Members

Discussion took place on the possibility of reallocating the funds for the second Annual Member's Bursary package to be used for offering members travel packages for the AICD courses.

It was agreed that 4 x \$500 travel packages be offered.

successful in acquiring a scholarship to attend the AICD courses.

At this meeting, the Department indicated they would like to continue to work with ALGWA and put forward a scholarship proposal for ALGWA members to undertaken several AICD courses.

Training dates and venues have been confirmed as:

- Foundations of Directorship 29/30/31 May 2019 from 8am 5pm, Meeting Room 3, 111 George Street, Brisbane.
- Governance Essentials 16/17 May 2019 from 8am 5pm, Day 1 in training room 14.02 and Day 2 in TR 14.14 on Level 14, 1 William Street, Brisbane.

The 2 courses being offered under the scholarship are:

- Foundation for Directorship Program (3 days); and
- Governance Essentials for Local Government Program (2 days).

These courses are strictly for ALGWA members and will not be public programs. To apply, applicants must submit an application supported by their council, include a copy of their resume and provide a statement as to what they want to undertake the program.



The following application criteria must also be met:

Local government officers

- 1. Minimum of two years' experience in a related position in local government
- 2. Relevance of the qualification to the candidate's position
- 3. Qualification does not duplicate previous studies undertaken by the staff member

Elected members

- 1. Preference will be given to councillors from small rural, remote and Indigenous local governments.
- 2. Councillors are required to provide a statement in support of their application (i.e. in terms of how undertaking the particular program or unit will assist their professional development in being a more effective elected representative for their community), and councillors must provide evidence of endorsement of their application by their council's mayor, including a commitment by council to support the councillor in completing the program wherever possible.

The Department of Local Government has also advised that they will cover the airfares and accommodation for rural, remote and indigenous councils. A list of the councils that qualify is detailed below:

 - how to empower yourself as a public speaker and storyteller; and
 - how to ensure you engage your audience.

BACKGROUND INFORMATION

At previous workshops, a significant amount of work has been undertaken to develop ALGWA's mission and goals and objectives.

Any marketing material needs to be updated to include this information.

Social Media

ALGWA Queensland Branch doesn't really have a social media presence. There is an established LinkedIn page which require rejuvenation. There is no facebook page or twitter account.

Marketing Material

There is limited marketing material with a high reliance on pushing traffic towards the website. A 3 fold brochure was developed several years ago which requires updating to reflect AGLWA's mission and include the benefits of being a member of ALGWA.

Print media is currently underutilised. There could be opportunity to place articles in industry magazines

Website

A new website was established in 2016 to align with the National Website. This is ALGWA's main promotional presence.

The website does have some limitations such as the number of pages able to be placed on the website. Complex updates to the website also need to be referred to Think Graphic Design which incur a cost.

The Publicity Officer, Nikki Te Wano, regularly maintains the website.

There could be opportunity to increase traffic to the website by providing resources etc.



Future Partnership Opportunities

Jilinda Lee, Zone 1 Representative has recently secured a partnership agreement with Australian Womens Leadership.

Developing further partnerships will provide an opportunity to increase awareness of ALGWA and also provide benefits to members.

Conference

ALGWA delivers a biennial conference with consideration of hosting a leadership forum in the alternate year.

A conference was held in 2018 hosted by Hinchinbrook Shire Council which was very well received by those who attended. Attendance levels were lower than the previous conference, however, this could be due to the regional location as the 2016 conference was held in Brisbane.

ALGWA partnered with the Local Government Manager's Association in 2017 to deliver a 1 day leadership forum.

Moving forward, ALGWA will need to consider whether an event be held in 2019 and if so, what format.

CONCLUSION

The promotion of ALGWA will play an important role in continuing to grow membership and ensure we remain relevant.
