## **POLICY**

### **HONORARY MEMBERSHIP**

**Objective:** To recognise people who have made an outstanding contribution to the promotion and furtherance of ALGWA (Qld) ideals.

**Eligibility:** Honorary Membership is for a period of one (1) year and may be granted to any person who is deemed by the Management Committee to have made, or the Management Committee considers may make, a significant contribution to the Association.

**Entitlements:** Honorary Members shall be exempt from payment of the annual subscription and may attend but not vote at general meetings nor nominate for Management Committee positions.

**Nomination and Election for Honorary Membership:** To nominate for Honorary Membership a nomination form must be completed and signed by two full members of the Association.

Election of Honorary Members shall be determined by a simple majority vote of the Management Committee.

**Termination of Honorary Membership:** Honorary Membership is terminated at the end of the term for such membership as has been determined by the Management Committee. The Management Committee may extend an honorary membership for an additional period and may revoke an honorary membership at any time.

**Removal from Honorary Membership:** Removal of an Honorary Membership Award may occur where the person:

- (a) is convicted of an indictable offence; or
- (b) fails to comply with any of the provision of the constitution; or
- (c) conducts themselves in a manner considered to be injurious or prejudicial to the character and interests of the association, the management committee shall consider whether the member's membership shall be terminated
- (d) the member will be given a full and fair opportunity of presenting their case and if the management committee resolves to terminate the membership, it shall instruct the secretary to advise the member in writing accordingly.
